**Please note the following expansion of Regions (as shown in bold zip codes below) applicable to the Temporary Suspension of Property Underwriting Authority related to the Southern California Fires.**

Effective immediately, for the **revised** territories identified below, there is a moratorium on any new business. Additionally, for any exposures in the moratorium area on renewals or existing business, underwriters:

1. Cannot increase limits.
2. Cannot add new locations.
3. Cannot make any changes that broaden existing coverage or lower deductibles.

## 1. **Event:**

1. Palisades Fire (near Pacific Palisades, Los Angeles County, CA)
2. Eaton Fire (near Altadena, Los Angeles County, CA)
3. Hurst Fire (near Sylmar, Los Angeles County, CA)

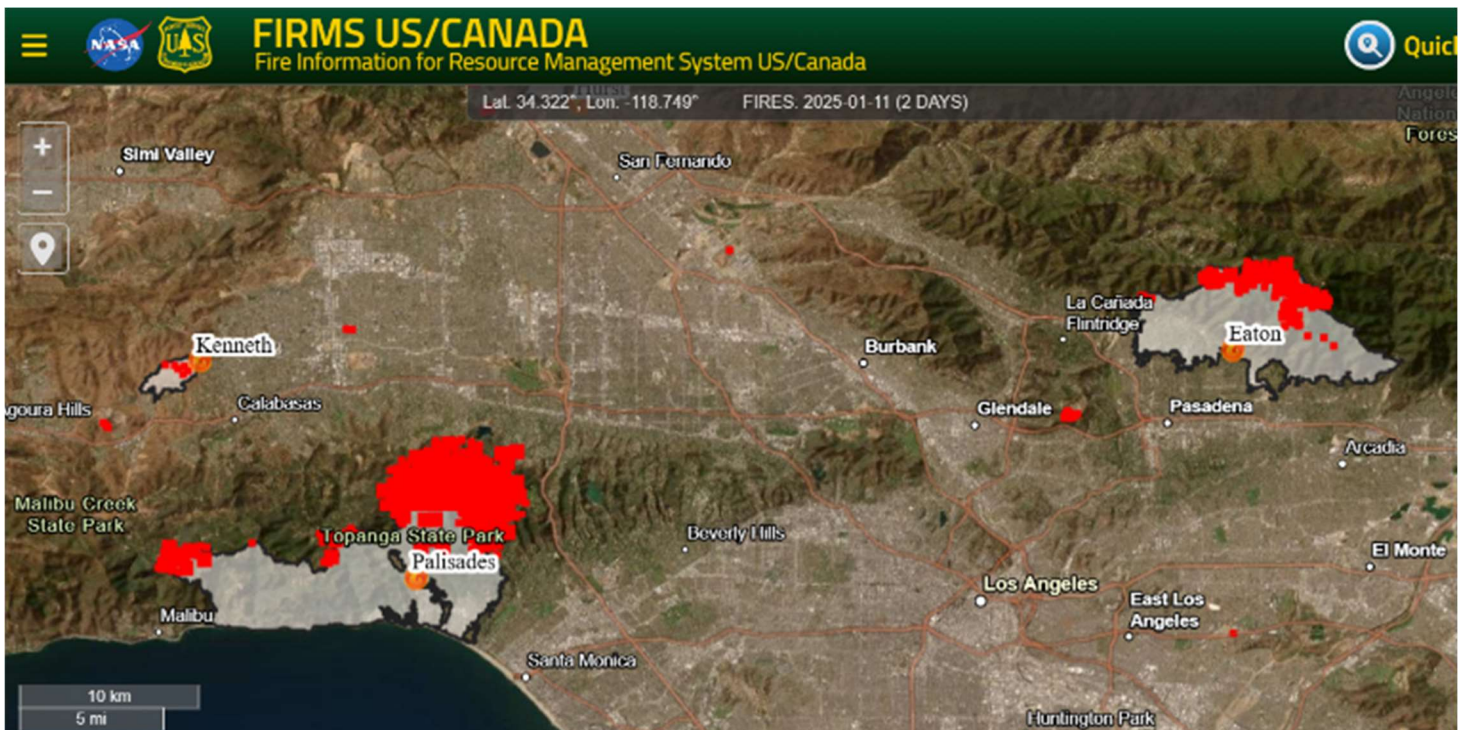
## 2. Event Details:

1. Fires across the Los Angeles area have killed at least 24 people, destroyed more than 12,000 structures and scorched more than 60 square miles as the Palisades and Eaton wildfires still burn in Southern California
2. Firefighters are bracing for more Santa Ana winds Monday – a red flag warning is in place until Wednesday across parts of Los Angeles and Ventura counties
3. The Palisades fire has burned 23,713 acres and is currently 14% contained. Most recently last week evacuation zones were expanded for the Encino and Brentwood areas.
4. The Eaton Fire has burned 14,117 acres and is currently 33% contained
5. The Hurst Fire has burned 799 acres and is 95% contained

## 3. Moratorium Duration:

1. This moratorium will remain in place until further notice.
