2. Event Details:


- 1. Hurricane Beryl currently has maximum sustained wind speeds of 70 mph (110 km/hr) and is located approximately 105 mi (170 km) SSE of Matagorda, Texas.
- 2. Beryl is forecast to bring damaging hurricane-force winds to portions of the Texas coast tonight and early Monday.
- 3. A Storm Surge Warning is in effect for Port Aransas to Sabine Pass, including Matagorda Bay and Galveston Bay.
- 4. A Hurricane Warning is in effect for the Texas coast from Port Aransas northward to San Luis Pass.
- 5. A Hurricane Watch is in effect for the Texas coast north of San Luis Pass to Port Bolivar.

3. Moratorium Duration:

1. This moratorium will remain in place until further notice.
