Due to continued utility outages in parts of Texas following Hurricane Beryl, it has become necessary to reinstate a partial property underwriting moratorium. As such, effective immediately, for the specific Texas counties identified below, there is a moratorium on any new business. Additionally, for any exposures in the moratorium area on renewals or existing business, underwriters:

1. Cannot increase limits.
2. Cannot add new locations.
3. Cannot make any changes that broaden existing coverage or lower deductibles.

The moratorium covers the following areas:

1. **The State of Texas – Counties of Brazoria, Fort Bend, Harris, Liberty, Montgomery, San Jacinto**

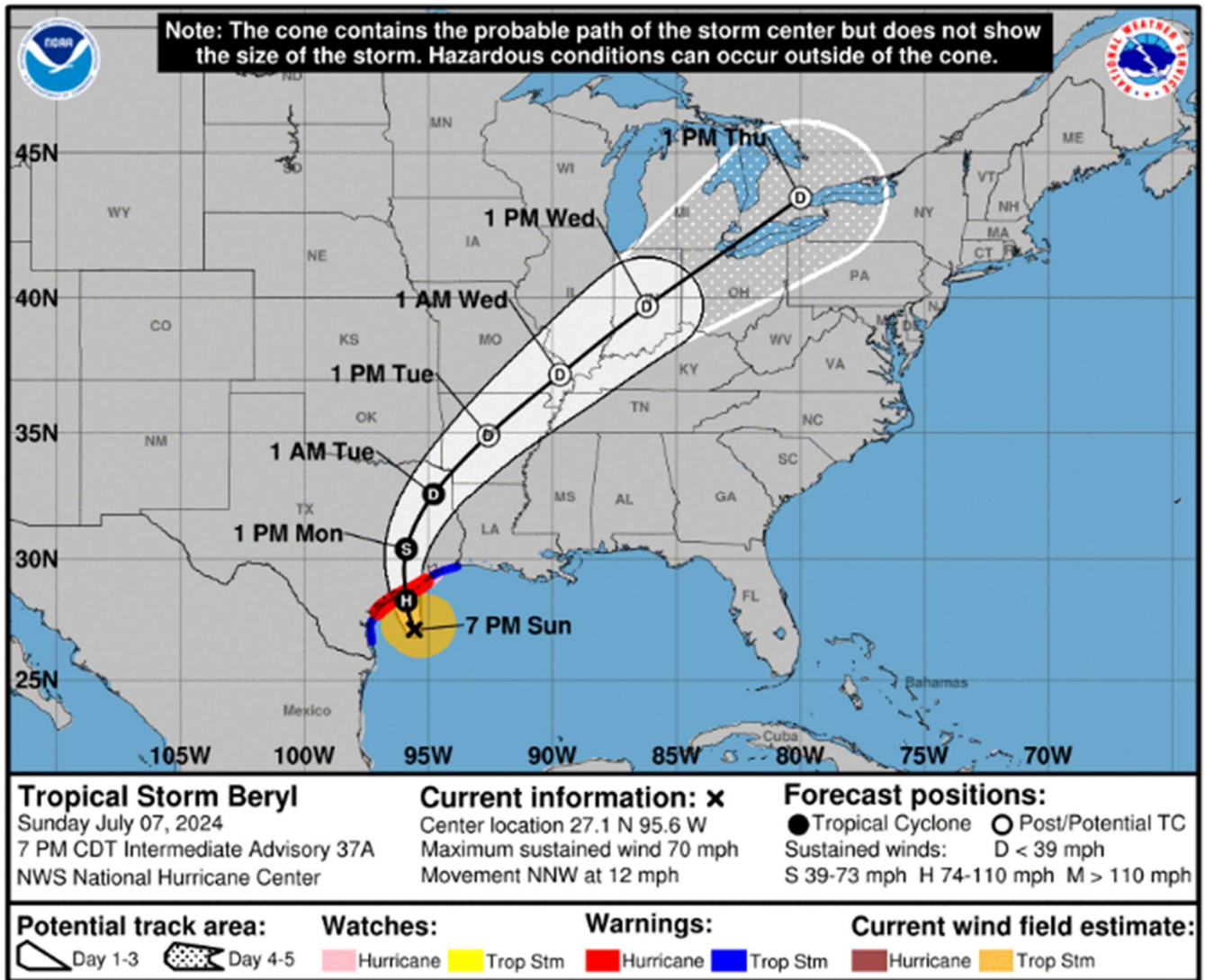
1. Hurricane Beryl currently has maximum sustained wind speeds of 70 mph (110 km/hr) and is located approximately 105 mi (170 km) SSE of Matagorda, Texas.
2. Beryl is forecast to bring damaging hurricane-force winds to portions of the Texas coast tonight and early Monday.
3. A Storm Surge Warning is in effect for Port Aransas to Sabine Pass, including Matagorda Bay and Galveston Bay.
4. A Hurricane Warning is in effect for the Texas coast from Port Aransas northward to San Luis Pass.

5. A Hurricane Watch is in effect for the Texas coast north of San Luis Pass to Port Bolivar.
