
Post-Tropical Cyclone Debby

2. Event Details:

- Debby made a second landfall in the U.S. as a tropical storm near Bulls Bay, Charleston County, South Carolina at around 06:00 UTC (02:00 local time) on Thursday August 8. At landfall, the system had maximum sustained wind speeds of 50 mph (85 km/hr) and a minimum central pressure of 995 hPa.
- 2. Debby previously made landfall as a Category 1 hurricane near Steinhatchee, Taylor County, Florida at around 11:00 UTC (07:00 local time) on Monday August 5. At this landfall, the system had maximum sustained wind speeds of 80 mph (130 km/hr) and a central pressure of 979 hPa.
- 3. Debby brought hurricane-force winds, damaging storm surge, and heavy rainfall to portions of Florida's Big Bend region and Gulf coast. It then brought heavy rainfall to Georgia and the Carolinas as it meandered over the North Atlantic near the coast for several days.
- 4. Heavy rainfall across portions of coastal South Carolina and North Carolina is expected to persist through Friday August 9, which will likely bring further flooding. As the system continues north, heavy rainfall will likely result in considerable flooding impacts across the Carolinas, portions of the Mid-Atlantic, and New England through the morning of Saturday August 10.
