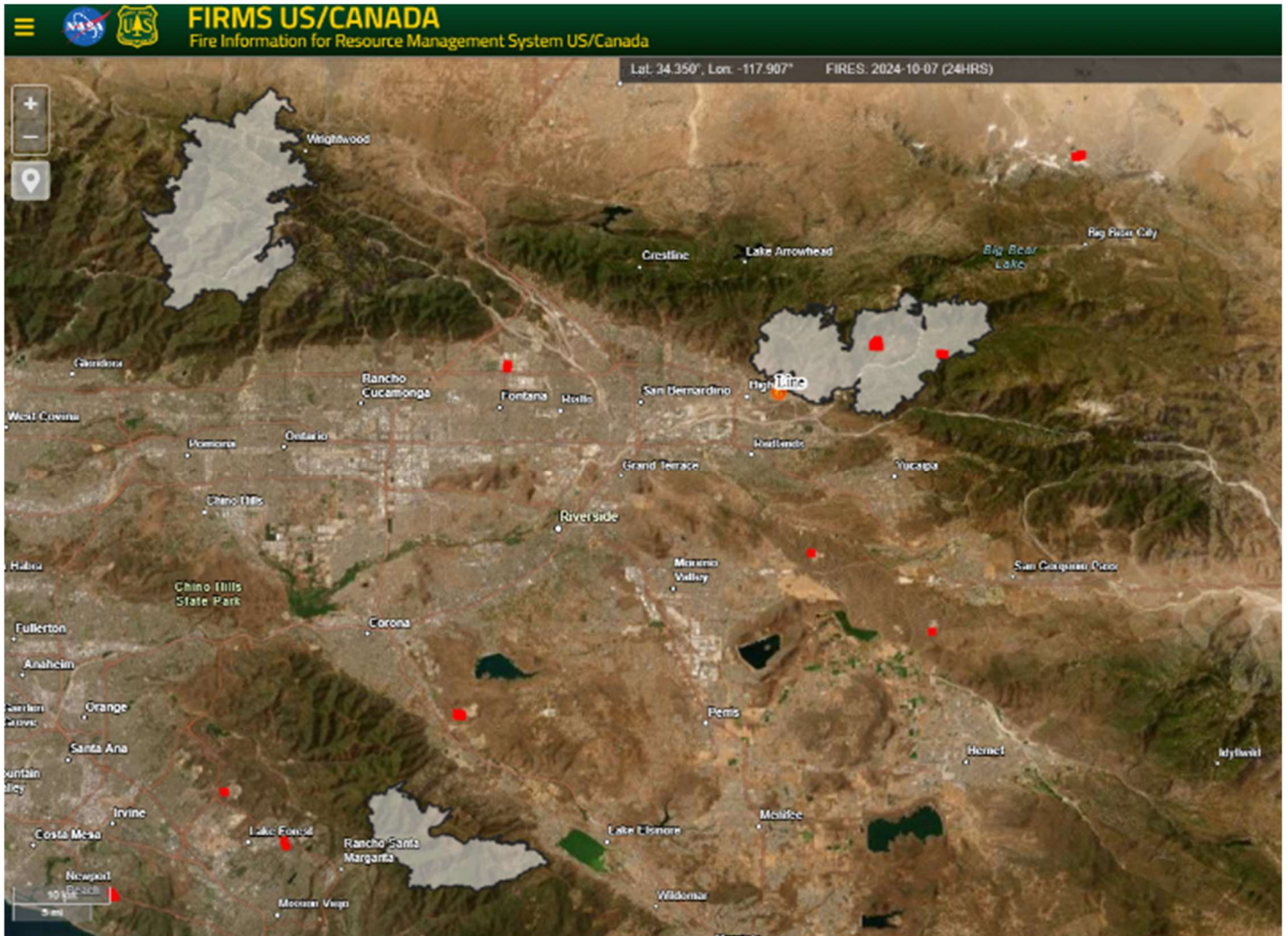
2. **Event Details:**

1. The Line Fire has burned 43,978 acres and is 87% contained. Evacuation orders and warnings remain in effect.
2. The Airport Fire burned 23,526 acres and is now fully contained.
3. The Bridge Fire has burned 54,878 acres and is 99% contained.

3. **Moratorium Duration:**

1. This moratorium will remain in place until further notice.

4. The Line Fire has burned 37,207 acres and is 18% contained. As of Sept. 12th, it threatens 65,100 structures.
5. The Airport Fire has burned 23,410 acres and is 5% contained. As of Sept. 11th, it threatens 10,500 structures.
6. The Bridge Fire has burned 51,167 acres and is 0% contained. As of Sept. 11th, it threatens 1,068 structures.
