Hurricane Helene


2. Event Details:

- 1. Hurricane and tropical storm conditions are expected over northeastern portions of the Yucatan Peninsula of Mexico today
- 2. Due to the large size of Helene, there is a danger of life-threatening storm surge along the entire west coast of the Florida Peninsula and Florida Big Bend. The highest inundation of potentially greater than 12 ft is expected along the Florida Big Bend coast.
- 3. Hurricane-force winds are expected across portions of northern Florida and southern Georgia where the core of Helene moves inland, with landfall forecast for Thursday
- 4. Because of Helene's expected fast forward speed, damaging and life-threatening wind gusts are expected to penetrate well inland over portions of the southeastern United States, including in the higher terrain of the southern Appalachians
- 5. Helene will bring potentially significant flooding across western Cuba and the northeastern Yucatan Peninsula into early Thursday
- 6. Considerable and potentially life-threatening flash and urban flooding is expected across portions of northwestern and northern Florida, the Southeast, southern Appalachians, and the Upper Tennessee Valley Wednesday through Friday
