
2. Event Details:

- 1. Hurricane Milton made landfall as a Cat 3 hurricane near Siesta Key in Sarasota County, Florida on Wed. Oct. 9th (local time)
- 2. As of Mon. Oct. 14th, Florida residents are grappling with power outages, gas shortages and persistent flooding caused by Milton
- 3. Hurricane Helene earlier made landfall as a Cat 4 hurricane near Perry in Taylor County, Florida on Fri., Sept. 27th
- 4. Western North Carolina roads are slowly opening back up after the remnants of Hurricane Helene caused mass flooding and landslides that deposited debris on roads, and in some cases washed them away entirely
- 5. Even though roads are becoming more accessible, the North Carolina Department of Transportation still cautions that only essential travel should be done on some of the hundreds of roads impacted by Helene

2. Event Details:

- 1. Hurricane Milton has strengthened to a Category 5 hurricane with maximum sustained winds of 160mph
- 2. Dangerous hurricane-force winds and a life-threatening storm surge are expected across portions of the northern coast of the Yucatan peninsula
- 3. Hurricane and Storm Surge Watches are now in effect for portions of the west coast of the Florida peninsula
- 4. "Milton will be a historic storm for the west coast of Florida," the National Weather Service in Tampa Bay said in a briefing Monday morning
- 5. Milton is expected to remain a major hurricane through landfall in Florida sometime later Wednesday into early Thursday
- 6. The latest National Hurricane Center forecast calls for storm surge to be as much as 8 to 12 feet above ground level if the peak surge coincides with high tide along the westcentral Florida Gulf Coast, including Tampa Bay. Low tide on much of the west coast of

Florida is Wednesday afternoon and high tide is Thursday morning. Storm surge will be most destructive near and to the south of where the storm's center crosses the coast.

7. Areas of heavy rainfall will impact portions of Florida today well ahead of Milton, with heavy rainfall more directly related to the system expected later on Tuesday through Wednesday night. This rainfall will bring the risk of considerable flash, urban, and areal flooding, along with the potential for moderate to major river flooding.
