INTRODUCTION OF NEW SPLIT PUBLIC PROTECTION CODES FOR IDAHO

KEY MESSAGE

This circular announces new Public Protection Codes for split-rated communities applicable to various property lines of business.

BACKGROUND

ISO developed its widely used Public Protection Classification (PPC) through the application of the Fire Suppression Rating Schedule (FSRS). The FSRS evaluates the key elements of a community's fire suppression system and assigns a point value for these various elements which determines that community's PPC grade.

INTRODUCTION

Currently, the Idaho Surveying and Rating Bureau's (ISRB) Public Protection Classification (PPC) manual specifies that in order to use the public protection class associated with distances to a fire hydrant/pumper connection, the property must be "within 5 miles of a fire station and within the stated distance to the hydrant/pumper connection as measured over roadways assessable to fire apparatus." Buildings in communities that are between 5-10 miles from a fire station are rated with PPC 1 through 8. Buildings in communities that are between 5-10 miles from a fire station and within 1,000 feet of a recognized water source are rated with PPC 9.

The ISRB Board recently approved a change that now recognizes hydrants between 5-7 miles from a recognized fire station in a fire district or community. However, to differentiate properties within 5-7 miles of the responding fire station **and** within 1,000 feet of a hydrant, the ISRB will be assigning a "W" to the corresponding PPC of that fire district or community.

As a result of the ISRB's approval and to accurately reflect reduced loss potential compared to single Public Protection Classification 1 – 8 communities, modifications to identify the new split-rated PPC class designations 1W through 8W will be needed.

ISO ACTION

A split-rated Public Protection Classification (PPC) is one in which properties within a given community may vary in class based upon differences in distance from a fire station and/or from a recognized water source.

Accordingly, ISO will establish additional Public Protection Codes for Idaho to distinguish jurisdictions listed as split-rated communities, i.e. Public Protection Classifications 1W through 8W apart from jurisdictions listed as single protection communities, i.e. Public Protection Classifications 1 – 10 in Idaho.

To provide data support for ISRB's 2018 Filing which will introduce Public Protection Classifications for split-rated communities in Idaho, we are making the following changes to all property lines of business in the ISO commercial and personal statistical plans:

- Establishing new Public Protection Codes which correspond to the Public Protection Class 1W through 8W for Idaho jurisdictions.

In addition, to maintain consistency and standardization across all ISO statistical plans, we are amending several PLSP(OTA) and PLSAP(OTA) split-rated Public Protection Classifications and will separately distinguishing these Public Protection Classifications with corresponding Public Protection Codes.

Note: While new Public Protection Codes are being added for split Public Protection Classifications in Idaho, the existing Public Protection Codes will remain unchanged for the non-split Idaho regions (i.e. regions listed with a single protection class).

COMMENT(S)

All coding changes:

- Apply to CSP, CSP-I, PLSP(OTA) and PLSAP(OTA).
- Do not apply to CSAP.

STATISTICAL REPORTING EFFECTIVE DATE

For statistical reporting purposes, these changes are effective for all transactions with an inception date of August 1, 2018 and subsequent on an optional basis and as of April 1, 2019 and subsequent on a mandatory basis.

FUTURE ISO ACTION

We will include these changes in:

- Fourth Quarter 2018 release of the CSP/CSP-I (Intermediate level).
- Fourth Quarter 2018 release of the PLSP(OTA) and PLSAP(OTA).
- First Quarter 2019 release of the Commercial Lines Company Edit Package (CEP).
- First Quarter 2019 release of the Personal Lines Company Edit Package (CEP).
