- Sexual Misconduct Liability Coverage expressly provided for the insured entity, as well as the bus driver. An accused bus driver is afforded protection until he or she confesses or is proven guilty of abuse allegations.
- Automatic inclusion of Terrorism Insurance for claims arising from acts of terrorism that impact school buses and their passengers.
