- 1) A corresponding change in the exposure base for the classification that rendered the ISO loss cost inappropriate; and (2) A conclusion that the ISO loss cost for the classification was inappropriate in light of the variability of exposures and risk types associated with sports accounts anticipated to be written in this program. For classifications necessitating (a) rating due to change in exposure base, the company approach to development of the (a) loss costs will be one of determining an estimate of the premium that would be developed for the risk via utilization of the "old" exposure base and then essentially reversing the calculation to determine a corresponding loss cost that would produce a premium commensurate premium level utilizing the "new" exposure base. Swimming Pools

Restaurants and refreshment stands

Sales of sporting goods
